- VII New Business
 - a) Inviting candidates for Precinct 1 Commissioner to speak at February meeting. Motion made by Tom and seconded by Sharon to invite candidates to attend the Tuesday, February 2 quarterly PSNA meeting. Maura will contact the 4 candidates running for County Commissioner Precinct 1. They are Arthur Sampson, Richard Franklin, James Nortey and Jeff Travillion. Each candidate will have a 2 minute presentation and a 10 minute Q&A will follow their presentations. The candidates will be at the top of the agenda followed by the guest speaker and the business portion of the meeting.

VIII Reports and concerns of board members

- a) Austin Energy sent a letter to PSNA announcing they will pruning and removing trees from near the electric lines starting in February, 2016. Contract notifiers will evaluate each property to determine proposed work to be done and will attempt to notify property owner with a door hanger or contact by telephone. Vicki will include this information in the January, 2016 newsletter.
- b) Taylor Lane Road Improvement Project Taylor Lane is currently a two-lane undivided roadway in Travis County with needed roadway repairs and expansion to support the future growth of the area. Travis County is considering modifications from the existing two-lane configuration to a four-lane divided roadway with median and bicycle lanes from Blake Manor Road to the future Braker Lane Extension.
 - Open House held on December 8, 2015 displayed maps that indicated 3 alternatives: <u>Alignment 1</u> East Alternative Widening (places 34 feet of new ROW on the east side of the existing ROW for the whole alignment duration.)<u>Alignment 2</u> (places approximately 17 feet of additional ROW on the east and west sides of the existing ROW of Taylor Lane.)

<u>Alignment 3</u> – Symmetric Alternative Widening (widens 34 feet to the west from Blake Manor to the Ella Louise Lind tract, shifts to widen 34 feet to the east from the Ella Louise Lind tract on to the Nelson Trust tract, and then shifts back to the west to widen 34 feet just north of the future Braker Lane Extension to the southern extents of the project. It was decided that Vicki will scan the handout provided at the Open House and provide it to PSNA members.
